- 1. Online Digitally Signed Tenders are invited for various exploitation platforms such as DTH Platform, Cable TV Platform, Mobile/Internet Platform and Satellite TV Channels from their authorized representatives.
- 2. Tenders may be submitted by any bidder providing the DTH, Cable, Mobile/Internet Services and Satellite TV Channels.
- 3. Tenders may be submitted for any of the following territories:
- (i) India Only, (ii) Entire World including India, and/or (iii) Entire World excluding India.
- 4. Blank Tender documents can be obtained & submitted online at www.mahatenders.gov.in
- 5. It is mandatory for the bids to be signed by a person of the post of Vice President or equivalent authority or Managing Director of respective service provider along with board resolution authorizing such person.
- 6. The Bidder/Service Provider should have annual turnover of at least Rs.4,00,00,000/- (Indian Rupees Four Crores Only) for last 03 (THREE) consecutive financial years.
- 7. The Bidder/Service Provider should have a minimum of 02 (TWO) years of experience in the field of broadcasting.
- 8. The Bidder/Service Provider shall be required to submit audited financial reports duly certified by their Chartered Accountants for the last 03 (THREE) financial years. The bidder/service provider shall submit PAN details also.

The bidder must possess necessary permissions from the Ministry of Information and Broadcasting, Government of India and/or from the applicable laws of other applicable territories/jurisdiction, for up-linking a Television Channel, for which the bidder shall submit necessary documentary evidence.

TENDER FOR LIVE DARSHAN OF LORD SIDDHIVINAYAK THROUGH DTH PLATFORM, CABLE TV PLATFORM, MOBILE/INTERNET PLATFORM AND SATELLITE TV CHANNELS.

Shree Siddhivinayak Ganapati Temple Trust (Prabhadevi), Mumbai (hereinafter referred to as Trust) has taken an initiative to broadcast Live Darshan of Lord Siddhivinayak on DTH Platform, Cable TV Platform, Mobile/Internet Platform and Satellite TV Channels for its Devotees across the world.

The period of contract will be for TWO (02) YEARS ONLY.

- As the term of contract is for TWO (02) YEARS, the Royalty for SECOND YEAR will have Mandatory Increment of 10% on FIRST YEAR in the Royalties.
- 1. The Trust is interested to broadcast the live video feed of Lord Siddhivinayak over DTH Platform, Cable TV Platform, Mobile/Internet Platform and Satellite TV Channels for different territories.
- 2. The Trust shall provide live/linear video feed of the Lord Siddhivinayak to the respective selected service providers. Such service providers shall retransmit the same live/linear video feed of the Lord Siddhivinayak to its authenticated subscribers on AS IT IS basis, without editing or altering the live/linear video feed, in any manner whatsoever.
- 3. It is expressly clarified that service providers shall not be entitled to add or delete or edit/alter the live/linear video feed of the Lord Siddhivinayak and further shall not insert advertisement (commercial or non-commercial) during the live feed without written permission from the Trust. However it is clarified that the service provider shall have option to insert advertisements only during the start of the live feed of the Darshan and that no such advertisements or banners etc. shall be inserted/provided during and between the live feed of the Darshan.

- 4. The service provider shall further have the option to provide catch up transmission services to its subscribers, which shall be limited for a maximum period of 7 (seven) days from the date of its first broadcast. Further, it is expressly clarified that such catch up transmission feed should be the same and exact feed; and there should not be any alternation or editing etc.
- 5. Trust shall provide the live/linear video feed of the Lord Siddhivinayak on commercially reasonable effort basis with 90% efficiency and the Trust shall not be liable for any claims if such live/linear video feed of the Lord Siddhivinayak is not available due to any reasons including but not limited due to force majeure events such as fire, earthquake, flood, pandemic, covid-19 restrictions, lockdown, restrictions imposed by the Government Authority, rains, epidemic, war, riots, acts of God, actual or threatened terrorism, technical failure, government orders, damage to the recording equipment, etc. and/or acts/reasons/events which are beyond the control of Trust and cannot be predicted by men of ordinary prudence.
- 6. All other charges including payment of Internet Leased Line charges, etc required for sending video feed from Shree Siddhivinayak Ganapati Temple Trust, Prabhadevi, Mumbai-400028 to service provider/bidder location should be borne solely by the service provider/bidder.
- 7. The selected bidder will have to pay an advance amount of 50% (Fifty Percent) of annual charges by RTGS only. This will be mandatory.
- 8. The Bidder will have no rights on the Recorded/Live Feed during or after contract therefore this period & also cannot use media/feed/content for any purpose including broadcast/publicity/sales/merchandising purpose, save and except for re-transmitting the same as permitted hereunder.

- 9. All the intellectual property rights including the copyrights and all other exploitation rights in the recorded/live feed shall vest exclusively with the Trust i.e., the successful Bidder/s shall only have the limited non-exclusive license to re-transmit the recorded/live feed provided by the Trust during the contract period on its channel. Further, notwithstanding anything mentioned in the Tender elsewhere, it is expressly clarified that all rights to screen live feed of the Darshan on YouTube and Websites are solely reserved by the Trust.
- 10. The successful bidder/s shall not have any sub-licensing or syndication rights to sub-assign/sub-license the rights to any third party and further the successful bidder/s shall also not have any right to grant any clip rights/sync rights of any part of the recorded/live feed to any third party, in any manner whatsoever. However, the Trust, on a case-to-case basis, may permit the service providers/bidders to sub-license the re-transmission rights to any third party, in writing.

The service providers will have to mandatorily provide complete details and other terms and conditions of such arrangement with third party sub-licensees and the Trust may provide its consent in writing on caseto-case basis.

The service provider/bidder hereby expressly agrees and undertakes that, in the event the written consent of the Trust is provided to any service provider for syndication/sub-licensing of the re-transmission rights, then the service provider/bidder shall pay 50% (Fifty Percent) of all the revenues, consideration and/or income received by the service provider from such third party sub-licensee, to the Trust, within 30 (thirty) days from the date of consent provided by the Trust to the service provider.

11. The selected bidders shall not have any rights to exploit the live/linear video feed or recordings of the same on any other platform save and except on their authorized platform/channel. The selected bidders shall have the obligation to exhibit the live feed of the Darshan on its authorized platforms and channels 24x7x365 i.e., at all the time during the entire year, during the contract term.

- 12. The Live Feed Transmission on the platform/channel will not have any tickers or banners or slots or advertisements of any kind whatsoever.
- 13. Subject to obtaining written permission from the Trust from time to time, the Service Provider shall be provided access of the Shree Siddhivinayak Temple for recording special events to be held at the Shree Siddhivinayak Temple (such as Angarak Sankasht Chaturthi) so that the viewers of such service providers can watch these events on live basis on the authorized channels/platforms.
- 14. The service providers shall further be entitled to record the live feed of certain special days of Shree Siddhivinayak (such as Angarak Sankasht Chaturthi) and provide access of the recorded feed to its viewers through the authorized channels/platforms throughout the year. Further, it is expressly clarified that such recorded feed should be the same and exact feed; and there should not be any alternation or editing etc.
- 15. The bidders shall not be entitled to white label or tie up or integrate with any third party platforms/channels for Live Feed Transmission in any manner including but not limited to by way of API integration, embedding, SDK, App in App integration etc.
- 16.Bidder should provide help desk on 24x7x365 basis & it should be displayed during live feed transmission.
- 17. Trust reserves its right to stop the recorded/live feed at any time at its sole discretion by giving prior notice. In the event of such cancellation/termination by the Trust, the successful bidder shall not have any right to make claim for any damages from the Trust and the successful bidder shall be liable to only pay for the period until such cancellation/termination.

18. Canvassing in connection with the tender in any form is strictly prohibited, and if resorted to, will render to the disqualification of the bidder.

Instructions for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the Govt. Portal, using valid Digital Signature Certificates. REGISTRATION

- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the Govt. Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g., Sify / TCS / nCode / eMudhra etc.) with their profile.
- 5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse, and the Trust should not be held liable or responsible for the same in any manner whatsoever.
